- 11% growth in overall attendance
- 142 people were baptized — including 14 kids and 63 students
- Over 700 first-time guests walked through our doors
- New ministries launched, new communities formed, and we made room for more people to find hope

While this growth has been exciting to see, it has also pushed us to our limit on Sunday mornings. That is why we announced in October that we will be adding a 3rd service in January 2026!

2024 Stronger Impact and 2025 Goals

Because of those who gave to Stronger in 2024, we:

- Refreshed our **Preschool** and **Auditorium** so first-time guests experience excellence the moment they arrive.
- Created a completely new **Kids Discovery Room** to serve the families with kids with autism and other special needs.
- Transformed the **Blue Room** into a permanent adult classroom—expanding our **Discover Track** to four classes offered all year.
- Gave **Volunteer Central** a facelift to give our amazing leaders and volunteers a much-needed thank you for all they do.
- Made two strategic hires—**Campbell and Gabby Sims**—who have already had a huge impact on both Wellspring Students and Next Steps. They are also helping our church to create our first **College and Young Adult** ministries.

Stronger 2025: Our goal is to be fully ready for our 3rd service in January by Dec 1st. To do that, we need you to:

Give - Create a Place for People

- Make a plan to support your church regularly in 2026
- Give a One-Time Gift to our Stronger Year-End Offering
 - Primary Goal: **Fund the full cost of launching the third service for one year — \$130,000.**
 - ~\$60,000 to cover increased fixed costs (utilities, supplies, etc.)
 - ~\$70,000 for proactive wear-and-tear replacements (200 auditorium chairs, 2 AC units, preschool & kids theater ceiling tiles)
 - Two Supporting Needs:
 - **\$30,000** to secure **Q1 2026 operations**, smoothing the typical dip and protecting momentum.
 - **\$90,000** to **create staffing margin**—either **2 full-time** or **3–4 part-time** leaders—so we can disciple the people God is bringing.

Volunteer - Make a Difference for People

- To be fully ready for a 3rd service, we need to add 120 New Volunteers
- Join our 3rd Service Launch Team

Invite - Because People Matter

- Invite someone to Come Sit With Me in January 2026 (or before).

Non-Cash Giving Options (Scan the QR Code)

Giving doesn't have to be limited to cash. Non-cash gifts are a powerful way to support Wellspring while also providing significant tax advantages to you.

- Appreciated Stock - Donating stock directly avoids capital gains taxes and provides a charitable deduction for the full market value.
- Cryptocurrency - Digital assets such as Bitcoin or Ethereum can be given directly. Like stock, donating crypto avoids capital gains tax and provides a full-value deduction.
- Other examples include: Real Estate (land, homes, commercial property, etc.), Personal Property (art, jewelry, equipment, etc.), Business Interests, and more.

The Tax Benefits of Stock & Crypto Gifts - By donating appreciated stock or cryptocurrency directly to the church, you can:

- Avoid paying capital gains tax on the appreciated amount
- Receive a charitable deduction for the full fair market value of the stock
- Increase your giving impact without reducing your cash flow

This means you can give more to the ministry while maximizing your tax savings.
